September is Recovery Month and **Ray Isackila, Assistant Clinical Administrator of Addiction Recovery Services**, in partnership with UH Employee Assistance Program, will give a talk on Dual Diagnosis. Many patients with substance use disorders have a co-occurring mental health condition along with their addiction and

research shows that both need to be treated for a successful outcome. The presentation will be held on **Wednesday, September 26<sup>th</sup>**, in the Kulas Auditorium from noon to 1:00 PM. Bring your lunch and learn more about mental health and substance use disorders.

**The Center for Evidence Based Practices at Case Western Reserve University** in collaboration with Shawnee Mental Health Center, Inc., has developed The Integrated Treatment Tool: A Tool to Evaluate the Integration of Primary and Behavioral Health Care ©. This innovation was made possible as the result of a grant from the Substance Abuse and Mental Health Services Administration (SAMHSA). This new instrument is a 30-item planning and evaluation document which guides an organizational change process that facilitates the integration of primary and behavioral healthcare services.

**Patrick E. Boyle, MSSA, LISW-S, LICDC**, director of implementation services at the Center for Evidence-Based Practices, explains that the CEBP will use the new Integrated Treatment Tool to help organizations in Ohio and nationally begin the process of integrating primary healthcare into services for people with behavioral healthcare issues (e.g., serious mental illness

and co-occurring substance use disorders). Even if an organization is not able to embed primary care within its behavioral health facilities and services, the tool is still relevant and useful, because it helps organizations achieve important incremental goals, which, over time, add up. "This stage-wise approach is important," Boyle says. "It sets a realistic, manageable pace for achieving and sustaining change and improved outcomes over time. It identifies organizational components and clinical services that are most important for the organization to change and grow."

## Research:

The Discovery and Wellness Center for Children at University Hospitals is currently enrolling children ages 6-17 years for a research study. Subjects must have a primary diagnosis of bipolar disorder, schizophrenia spectrum disorder or any other psychiatric disorder requiring treatment with medication. If eligible, your child will receive a study-related evaluation, study medication and close follow up during the research study from a doctor who specializes in pediatric mental illness. ## Research Study

Study for older adults (≥ 60 years) with type I Bipolar Disorder who are currently sub-optimally

responsive to their prescribed BD treatments will receive 12 weeks of open-label Asenapine. Each study subject will serve as their own baseline control and mood symptoms will be assessed using standardized measures during the 12 weeks of Asenapine therapy. The primary outcome is change from baseline in bipolar mood symptom scores (mania and depression). Secondary outcomes include functional and general health status, global psychopathology, side effects, and extrapyramidal symptoms.

**To participate, individuals must:**

- 1.) Type I Bipolar disorder
- 2.) Age 60 or older
- 3.) Sub-optimal response to current psychotropic management including:
  - a. Behaviors and symptoms of irritability, agitation, mood lability or diminished ability to interact with others in their place of residence
  - b. Diminished ability to take care of basic personal needs in their place of residence due to symptoms of BD

**To participate, individuals may NOT have:**

- 1.) History of intolerance or resistance to asenapine
- 2.) Clinical diagnosis of dementia or Mini-mental state (MMSE) < 24
- 3.) History of TIA, stroke or MI within the past 12 months
- 4.) Medical illness that is the clear, underlying etiology of BD
- 5.) Unstable medical illness or condition including prolonged QT interval
- 6.) Substance dependence (except nicotine or caffeine) within the past 3 months.
- 7.) Rapid cycling BD defined as 4 or more discrete mood episodes within the previous 12 months.
- 8.) At high risk for self-harm or suicide

**Double-Blind, Placebo-Controlled Trial of Pioglitazone for Insulin-Resistant Bipolar Depression**

**PURPOSE:** Patients with bipolar disorder have higher rates of insulin resistance than the general population. Currently, physicians do not know whether treating insulin resistance in people with bipolar disorder will lead to a decrease in depressive symptoms. The purpose of this study is to test whether pioglitazone, a medication that improves the efficiency of how the body uses blood sugar, is able to reduce depression severity.

**ELIGIBILITY:** Participants must be over the age of 18 with Bipolar Disorder (I, II, NOS); currently receiving treatment with an anti-manic drug or willing to receive treatment with an anti-manic drug. The following are considered anti-manic drugs: lithium, divalproex, carbamazepine, lamotrigine, olanzapine, quetiapine, risperidone, aripiprazole, asenapine, or ziprasidone. Participants cannot have a history of bladder cancer or heart failure. Participants cannot be diagnosed with dementia or taking insulin or rosiglitazone.
